ON PICKUP TRUCKS

Commercial Plates Now Needed to Haul Boats

Capitol News Service SACRAMENTO — The confusing pattern of regulations of what an owner of a pickup, registered with passenger license plates, can haul slid further into the gray area this week with an attorney general's ruling that motorcycles, boats and outboard motors are taboo. More and more Californians who like the out of doors have been turning to pickups for their transportation of late. Many use them during most of the year for commutes, cars, or even a family car, and have no intention of using them for commercial purposes. But the law provides that pickups registered as passenger vehicles may not haul "property," whether it belongs to the owner or is on a for-hire basis.

TO FACILITATE enforcement of this obscure law, to a certain extent, the Department of Motor Vehicles and California Highway Patrol have a "list" of items which may be hauled legally with the passenger plates and those which may not. The new ruling outlawing the hauling of motorcycles, boats, or outboard motors may change things a bit. The simple answer for any pickup owner, of course, would be to pay the full weight fees for commercial registration, about \$17. But many pickup owners resent the idea of buying commercial licenses for vehicles which are not used commercially.

WHEN A pickup owner registers his vehicle with passenger plates, he must sign a statement that he will not haul "property." A violation of this results in a citation plus the immediate requirement to pay the full commercial fees. Pickups registered for passenger use may haul suitcases, golf clubs, other personal sporting gear, including camping equipment, or groceries. But they may not carry trash, grass clippings, a bag of fertilizer or feed, or a bale of hay. On the other hand, a person with a station wagon may haul anything he can get into the vehicle and do it legally. The same goes for standard passenger cars.

OVER THE years, several legislators have become concerned about the confusion of this law. The most recent was Assemblyman John Vasconcellos (D-San Jose). Vasconcellos, a brand new legislator in 1967, attempted to pass a bill which would permit hauling of any goods with passenger plates on a pickup, if it was not done commercially. But Vasconcellos' bill got no further than other bills have in recent years. The main reason for continuing the confusing law is that the Department of Motor Vehicles has resisted a change on the basis of possible revenue losses. In mid-1967, there were about 999,000 pickups registered in California.

OF THAT total, 111,000 were registered as passenger vehicles and the bulk of 888,000 were registered commercially. Simple arithmetic shows that the 880,000 commercially-registered vehicles paid some \$15 million in weight fees. Permitting all pickups to be registered as passenger vehicles thus would result in that much of a loss to the state. On the other hand, as has been suggested, if the difference were split and all pickups paid an additional fee—regardless of commercial or passenger—this would require about \$15 per vehicle. For the passenger, non-commercial user, this would be little better than paying commercial fees. There has been little indication anything would do, despite its confusion. The new attorney general's ruling no doubt will merely add to the confusion.
