Bond Sale Authorized By Board

Sale of \$5 million in school bonds was authorized by the Torrance Board of Education Monday evening.

The sale is the second from a \$9 million bond issue approved by voters at the Nov. 8 general election. A total of \$1 million in bonds was sold just after the election.

Some \$950,000 in building funds is available at the present time, although progress payments on projects under way will account for nearly \$700,000 of those funds.

The bonds will be sold May 16 and will be dated for June 1, the board was told. Approval of the Los Angeles County Board of Supervisors is required before the sale will be authorized.
