Vietnam Veterans Need Jobs

Veterans, who have made the transition from the rice paddies of Vietnam to their homes in Torrance, are in need of jobs, according to Matthew Nadalin, manager of the Torrance office of the California state employment service, 1016 Sartori Ave.

What's more, their technical training, their discipline, and their solid, responsible behavior make them ideal employees, Nadalin said. Older veterans,

who are unemployed through no fault of their own, have equally good qualifications, Nadalin said. Additionally, many of them have received education or training under the GI bill.

Although the state employment office gives special services to veterans the year around, May 12 through 17 has been proclaimed "Hire a Veteran Week" by Mayor Albert Isen and the Los Angeles county board of supervisors. It has been endorsed by Governor Ronald Reagan.

Broadway Choreographer To Speak at El Camino

Ballet choreographer of Broadway musical shows, Anges De Mille, will lecture in the El Camino College Campus Theater, Wednesday, May 14, at 8 p.m.

\$98.6 Million Added to Tax Rolls Through Audit

County Assessor Philip E. Watson today announced that \$98,600,000 in escape and penalty assessments were added to the assessment roll as a result of the 1968-69 audit of business property affidavits conducted by his audit staff.

This will result in an additional tax collection of more than \$9 million for local taxing agencies, Watson said, pointing out that in the six years his department has been auditing business property declarations, a total of \$392 million in additional assessed value has been recovered by the county for a six-year additional tax collection of almost \$33 million.

This past year's audits involved 8,400 documents, the assessor explained, that figure being 1,100 higher than last year.

STATE LAW now prescribes a flat 25 per cent penalty for willful under-reporting. This is a reduction from a 50 per cent penalty allowed until two years ago, and a change in the law which originally allowed penalties of up to 1,000 per cent.

Watson's audit program was begun in 1963, his first year in office, under state law which left auditing up to the policy of the individual assessor. Under provisions of AB 80, passed in 1966, assessors must now audit, at least once every four years, businesses with a market value in personal property of more than \$50,000.

After the mandatory audit program was passed, the six other southern counties of the state joined together with Los Angeles County in a joint-county audit program in which

one county audits for all the counties in which a company is doing business.

THIS SAVES time and money for both the counties and the businesses being audited since a single audit trip can do the job of several.

Marvin Blatt, chief of the Los Angeles County Audit Division, is now serving his third year as president of the Joint-County Audit Program.

Watson said the cooperative audit program represents a real savings to the taxpayer. The State Board of Equalization makes out-of-county audit service available to any county, but the average state board charge this year was about \$200 per audit, while cost per audit in Los Angeles County has averaged only about \$80, the assessor added.


Airport Meeting
